Return Policy

If within 14-days, you are unsatisfied with your purchase, you may return it for a refund (less shipping costs).

All merchandise will be charged a 20% restocking fee unless it is our error. Closeout items are not returnable. Undergarments are not returnable unless the original package has not been opened.

Absolutely no returns on any customized garments, Engraved products and Promotional material. Embroidery and screen printed garments are defined as customization.

Please be sure to follow washing and handling instructions carefully as Strike Force Uniforms does not give returns or exchanges due to mis-washing of products.

Returned goods must not be used, worn, are in marketable condition and returned in original packaging. Returns after 14 days will not be accepted. Exceptions to the restocking fee may be offered to deployed US military personnel.
